The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

Article 1 - Name and Address

The name of this Corporation shall be Gold and Silver Bullion, Inc. and the principal place of business shall be 23110 State Road 54, #265, Lutz, Florida 33549-6933, or at such other place as may be designated by the Board of Directors.
