

The undersigned hereby organizes a corporation for profit under the provisions of the
Professional Service Corporation Florida Professional Service Corporation and Limited Liability Company Act, and pursuant to the following Articles of Incorporation.

ARTICLE 1

Name

ARTICLE 2

ARTICLE 3

CORPORATION PURPOSES, POWERS & RIGHTS
