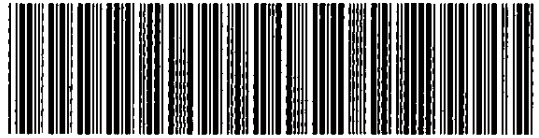

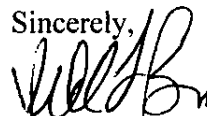

The undersigned hereby organizes a corporation for profit under the provisions of the Florida Professional Service Corporation and Limited Liability Company Act, and pursuant to the following Articles of Incorporation.

ARTICLE 1

Name

The name of this corporation is: **MELVIA B. GREEN, P.A.**

ARTICLE 2

Mailing Address

ARTICLE 3

CORPORATION PURPOSES, POWERS & RIGHTS

The nature of the business to be conducted or promoted and the purposes of the corporation are to engage in the practice of **LAW and any other** lawful act or activity for which a professional service corporation engaged in such profession may be organized under the Professional Service Corporation Act and Limited Liability Company Act ("Act"), and in which such a corporation is permitted to engage under applicable law.
