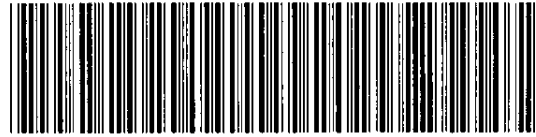

ARTICLE I - NAME

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE
