

The undersigned, for the purpose of forming a for-profit corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation.

ARTICLE I
NAME

The name of the corporation shall be **DJ Ministries of Excellence International, Inc.** (hereinafter called the "Corporation").

ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS


