The undersigned subscriber to these Articles of Incorporation, being duly licensed to practice law under the laws of the State of Florida, adopts these Articles to form a corporation under the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, and other laws of the State of Florida.

**ARTICLE I. NAME**

The name of the professional service corporation is Garofalo Law Office P.A.

**ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal office and mailing address of this professional service corporation is 7740 N.W. 63<sup>rd</sup> Avenue, Parkland, FL 33067.

**ARTICLE III. PURPOSE**

The professional service corporation is formed to engage in every phase and aspect of the practice of law. 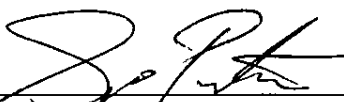
