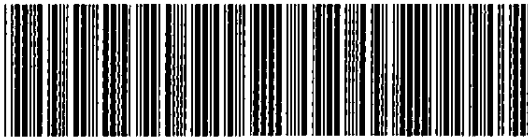

ARTICLE XII CALLING OF SPECIAL MEETINGS

ARTICLE XIII SHAREHOLDER QUORUM AND VOTING

The corporation shall indemnify any officer or director; or any former officer or director, to the full extent permitted by law.

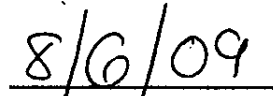
ARTICLE XXIV AMENDMENT

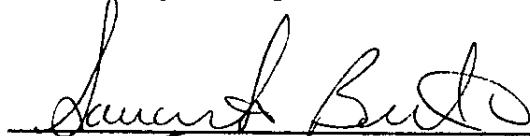

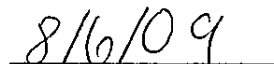

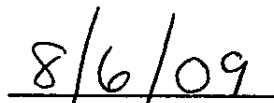
