ARTICLES OF INCORPORATION

OF

KING'S PRESSURE WASHING AND MOBILE DETAILING, INC.

THE UNDERSIGNED do hereby associate for the purpose of forming a corporation under the laws of the State of Florida, and do hereby certify as follows:

ARTICLE I - NAME

The name of the Corporation shall be: KING'S PRESSURE WASHING AND MOBILE DETAILING, INC.

ARTICLE II - PURPOSE

- A. To carry on and engage in the business of providing cleaning services for automobile; trucking and other related services including but not limited to detailing, customizing and caring for automobiles and other types of property whether personal or otherwise, in addition to any acts necessary and/or related thereto.
- B. To carry on and engage in any business or activity which may be authorized and permitted under and by virtue of the laws of the United States of America or the State of Florida.

ARTICLE III - CAPITAL STOCK

The corporation shall be authorized to issue capital stock in the following manner, to-wit: (1000) shares of common stock, having no par value.

ARTICLE IV - POWERS

The powers of the Corporation shall include all those conferred by the bylaws of the Corporation and the laws of the State of Florida.
