ARTICLE V: CAPITAL STOCK

The maximum number of shares of stock that the corporation is authorized to have outstanding at

any one time is seven thousand (7,000) shares of common stock having a par value of One (\$1.00) Dollar per

share.

By-Laws, but no decrease shall have the effect of shortening the term of any incumbent Director. The

number of Directors shall never be less than one (1).
