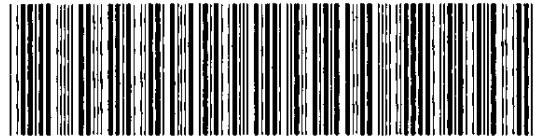

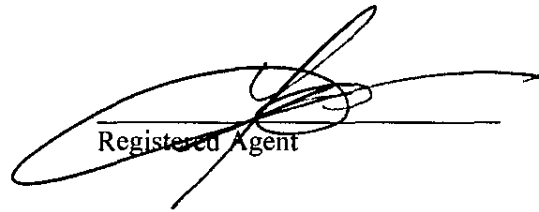

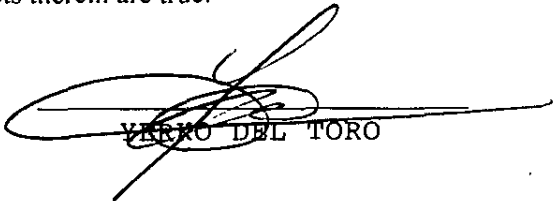
Article – Fourteen

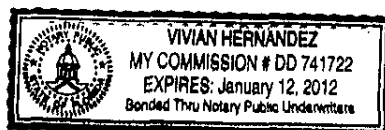
