## **ARTICLE 1**

#### **ARTICLE II**

The general nature of the business and the objects and purposes proposed to be transacted and carried on arc to do any and all of the things mentioned, as fully and to the same extent as natural persons might or could do, viz:

Generally to perform and make contracts of any kind and description and for the purpose of attaining any of the objects of the corporation, to do and perform any other acts or things, and to exercise any and all powers which a co-partnership or natural person could do and exercise, and which now are, or hereafter may be authorized by law and generally to do and perform any and all things necessary or incident to the performing and carrying out of the power hereinabove specifically delegated of implied.
