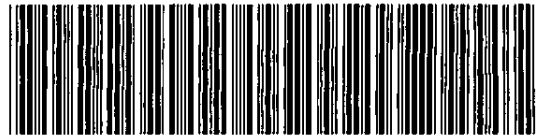

WE, DANIEL C. SHAUL and DIANA R. SHAUL, the undersigned, do hereby organize ourselves for the purpose of becoming a corporation for profit under Florida law.

ARTICLE I

The name of the corporation is: COMMISSARY SUPPLY OF EAST COAST, INC..

ARTICLE II

This corporation may provide and distribute all kinds of ice cream supplies and related products, and conduct other related enterprises not prohibited by law.

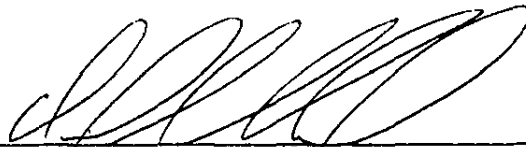
