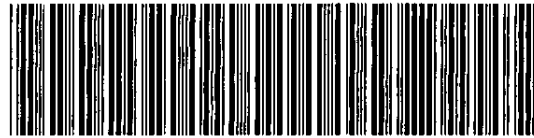

**ARTICLES OF INCORPORATION
OF
PREMIER CONSULTING PARTNERS, INC.**

ARTICLE I – NAME

The name of the Corporation shall be Premier Consulting Partners, Inc. (the “Corporation”)

ARTICLE II- ADDRESS

ARTICLE III – PURPOSE

The power to adopt, alter, amend, or appeal By-Laws shall be vested in the Board of Directors and the shareholders.

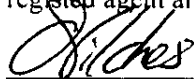
ARTICLE IX – INDEMNIFICATION
