The undersigned, acting as Sole Incorporator of a Corporation under the Florida Business Corporation Act, hereby adopts the following articles of Incorporation for such Corporation.

ARTICLE I. NAME

The name of this corporation is: PAT'S PLACE - ZEPHYRHILLS, INC.

ARTICLE II. PRINCIPAL OFFICE

The physical address of the principal place of business is: 37640 State Road 54, Zephyrhills, FL 33542, and the mailing address is: P. O. Box 365, Zephyrhills, FL 33539.

ARTICLE III. PURPOSE/NATURE OF BUSINESS

The general nature of the business to be transacted by the corporation is:

- A. To engage in the business of buying and selling alcoholic beverages to the general public on the premises; to own and operate business machines for the sale of sandwiches, cigarettes, candy, potato chips, and other items to be consumed by the general public on the premises
