**ARTICLES OF INCORPORATION
OF
FLORIDIAN LANDSCAPE AND SERVICES, INC.**

Pursuant to the provisions of Section 607.0202 of the Florida Business Corporation Act, the undersigned does hereby execute and submit for filing with the Florida Department of State these Articles of Incorporation as follows:

ARTICLE I - NAME

The name of the corporation is Floridian Landscape and Services, Inc.

ARTICLE II - ADDRESS

The principal office and mailing address of the corporation is 2666 Tigertail Avenue, #110, Miami, Florida 33133.

ARTICLE III - CAPITAL STOCK

The corporation is authorized to issue 10,000 shares of common stock, par value \$0.01 per share.

ARTICLE IV - REGISTERED OFFICE AND REGISTERED AGENT

The foregoing right of indemnification shall not be exclusive of any other rights to which any Directors, officer, employee or agent may be entitled as a matter of law or which he or she may be lawfully granted.
