

### ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a Florida professional service corporation, in compliance with Chapter 607 and Chapter 621, Florida Statutes, hereby adopts the following Articles of Incorporation:

## ARTICLE I - Name

The name of the Corporation is: The Health Law Hub, P.A.

## ARTICLE II - Address

The initial mailing address and street address of the principal office of the Corporation is: 901 NW 118<sup>th</sup> Terrace, Gainesville, Florida 32606

# ARTICLE III - Purpose

The purpose for which this Corporation is organized is to engage in every phase and aspect of the business of rendering professional legal services to the public; and to engage in any activities which will facilitate and promote the practice of law, or understanding of the law generally.
