The undersigned incorporator hereby makes, subscribes to, acknowledges and files these Articles of Incorporation for the purpose of organizing and incorporating a corporation for profits under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be **Evie Rider**, **Inc** and it shall be hereinafter referred to as the "corporation".
