

ARTICLES OF INCORPORATION  
OF  
VERDICORP, INC.

The undersigned hereby form a corporation-for-profit under the Florida General Corporation Act by adopting the following Articles of Incorporation:

1. Name. The name of this corporation is Verdicorp, Inc.
2. Nature, Purpose and Powers. The corporation shall have perpetual existence, commencing on the date that these Articles are executed and acknowledged with the power to engage in any lawful business and have all powers enumerated in the Florida General Corporation Act.
3. Capital Stock. The corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.
4. Initial Registered Agent and Office. The name and address of the initial registered agent of this corporation is: William D. Crona, 1471 Timberlane Road #126, Tallahassee FL 32312.
5. Initial Board of Directors. This corporation shall have two directors initially. The number of directors may be either increased or diminished from time to time by the Bylaws but shall never be less than one. The names and the addresses of the initial directors are: Ronald David Conry, 2704 Waterford Glen Court, Tallahassee FL 32312; and, William D. Crona, 1471 Timberlane Road #126, Tallahassee FL 32312.
6. Incorporators. The names and the address of the person subscribing to these Articles of Incorporation are: William D. Crona, 1471 Timberlane Road #126, Tallahassee FL 32312.
7. Indemnification. The corporation will indemnify any officer or director, or any former officer or director, pursuant to Section 607.014 of the Florida Statutes, as amended.


