SECTION I. MARITAL ASSETS AND LIABILITIES.

- A. Division of Assets. We divide our assets (everything we own and that is owed to us) as follows:
- 5. The parties own the business corporation Torsky, Inc. registered with the State of Florida on 02/10/2004, Document Number P04000025841. The Husband agrees that Mr. Ruslan Laishev can only be an employee in BE PLUS, Inc.
- 8. The Husband agrees that sale or transfer of any of corporate assets of business corporation BE PLUS Inc, or sale or dissolution of BE PLUS, Inc, cannot be done without Wife's, Mrs. Tatyana Laisheva knowledge, approval, and signature until 03/04/2015 (March Forth of Two Thousand and Fifteen), the 21st birthday of the minor child, common to both parties, Anna Laisheva.

- 9. The Husband agrees that transfer of all corporate assets, licenses, registrations, and other proper documentation from the business corporation Torsky, Inc to the business corporation BE PLUS, Inc should be done not later than December 20, 2009.
- 13. The Husband agrees that all business assets and property of the business corporation BE PLUS, Inc will be transferred back to the business corporation Torsky, Inc, in the event if he fails his obligation to pay child support in the amount of \$900.00 (nine hundred dollars) a month to the minor child Anna Laisheva until the child turns 21, or file for child support modification to reduce the amount of child support payments, or fails his obligation to re-pay the loan to Mr. Mikhail Mikhaylovich Torskiy, the Wife's father, in the amount of \$ of \$28,000.00 (Twenty eight thousand dollars).
- 14. The Wife agrees and confirms that after the minor child common to both parties, Anna Laisheva, born on 03/04/1994, reach her 21st birthday, and upon the full and total re-payment of the loan in the amount of \$ 28, 000.00 (twenty eight thousand dollars) to the Wife's father, Mr. Mikhail Mikhaylovich Torskiy, the Husband can manage the business corporation BE PLUS, Inc, at his sole discretion.
