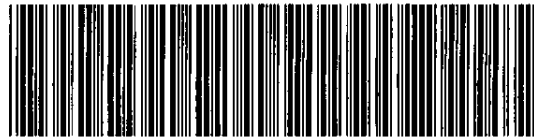

**ARTICLES OF INCORPORATION
OF
C Z ENTERTAINMENT, INC.**

ARTICLE I - NAME

The name of this corporation is C Z Entertainment, Inc.

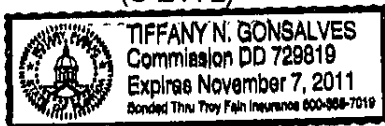
