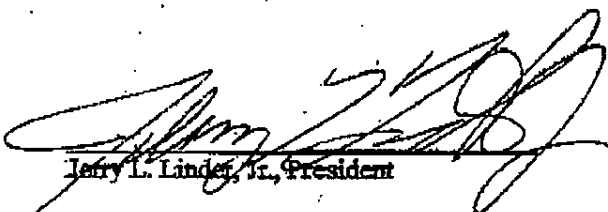

TO
ARTICLES OF INCORPORATION
