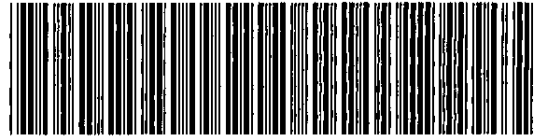

The name of this corporation is TRI COUNTY LANDSCAPE CONTRACTORS, INC.
