

ARTICLES OF INCORPORATION OF

CHANCE RESOURCE SUPPORTIVE SERVICES, INC.

ARTICLE I - NAME

The name of the corporation is Chance Resource Supportive Services, Inc., at 1960 Ohio Street NE, Palm Bay, FL 32907 (Principal Office)

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any of all lawful business.

ARTICLE IV - CAPITAL STOCK
