1. The name of the Corporation is **JUNIOR GOLF AUTHORITY, INC.** (the "Corporation").

2. Article I of the Articles of Incorporation of the Corporation is amended to read as follows:

Article I – Corporate Name

The name of this corporation shall be **ParKit Golf, Inc.**

3. This Amendment was recommended by the board of directors to the Corporation's shareholders on January 1, 2010.

4. This Amendment was unanimously approved by the holders of all of the Corporation's common stock, which is the only group of the Corporation's shareholders entitled to vote on the Amendment, and the number of votes in favor of the Amendment was sufficient for its approval.

5. This Amendment shall be effective upon the recording hereof.
