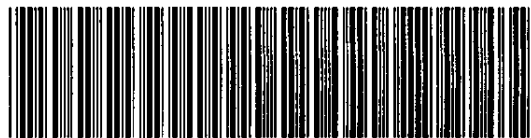

corporation which should have been dissolved previously but due to lack of knowledge and guidance did not do so.


