ARTICLES OF INCORPORATION
OF
GELA CONCEPTS INC

I, the undersigned, hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purposes of forming a Corporation for profit in accordance with the laws of the State of Florida.

ARTICLE 1 - NAME

The name of the corporation shall be: GELA CONCEPTS INC
The principal office shall be: 623 E Atlantic Blvd Pompano Bch Fl 33060

ARTICLE 2 - PURPOSES

The corporation may engage in the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Florida including, but not limited to design concepts services.

ARTICLE 3 - GENERAL POWERS

The corporation shall have all power to conduct its business, locate offices, and exercise the powers granted by law within the powers within or without this state.

ARTICLE 4 - CAPITAL STOCK

A) The total number of shares of capital stock authorized to be issued by the corporation shall be 10,000 shares having a par value of \$.10 per share. Each of said shares of stock shall entitle the holder thereof to one (1) vote at any meeting of the stockholders. The Board of Directors may authorize shares to be issued for consideration consisting of tangible or intangible property or benefit to the corporation, including cash, promissory notes, services performed, promises to perform services evidenced by a written contract, or other securities of the corporation. Before the corporation issues shares, the Board of Directors shall determine that the consideration received or to be received for shares to be issued is adequate. All stock when issued shall be paid for and shall be nonassessable.

B) In the election of directors of this corporation there shall be no cumulative voting of the stock entitled to vote at such election.

ARTICLE 5 - INDEMNIFICATION BY COURT ORDER

No director, employee, or agent of the corporation who is or was a party to a proceeding may apply to the court conducting the proceeding, the circuit court, or to another of competent jurisdiction, seeking indemnification or advancement of expenses, or both pursuant to Section 607.0850(9), Florida Statutes without the permission, by a majority vote of the disinterested directors, of the Board of Directors.

ARTICLE 6 - INITIAL REGISTERED AGENT AND ADDRESS

The name and address of the initial registered agent Angela Mugnaini, 623 E Atlantic Blvd Pompano Bch Fl 33060. The corporation may change its registered office or, registered agent or both by filing a statement of such with the Department of State of the State of Florida.

ARTICLE 7 - INITIAL STOCKHOLDER

The number of initial stockholders of the corporation shall be one, and their names and addresses and number of shares to be issued are as follows:

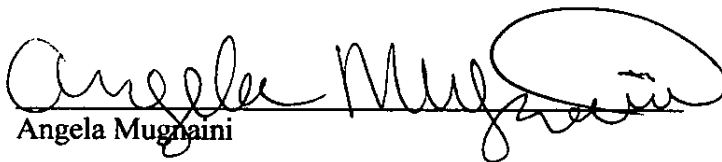
ARTICLE 10 - EFFECTIVE DATE

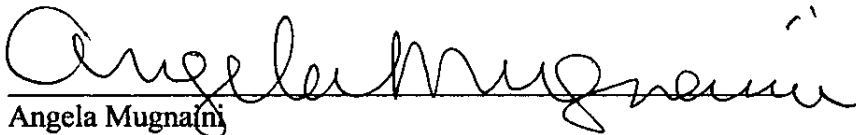

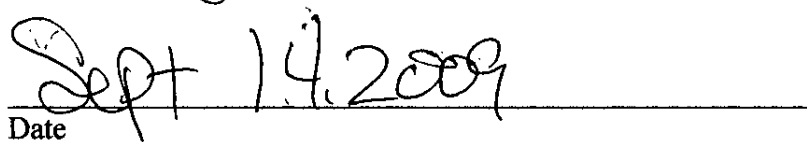
