ARTICLES OF INCORPORATION

of

The undersigned, pursuant to the Provisions of Section 607.0202 of The Florida Statutes does hereby and herewith file, with the Secretary of State of The State of Florida, these Articles of Incorporation for **DAVID CERVANTES INSURANCE, INC.**, a Corporation for Profit organized pursuant to the Laws of The State of Florida.

ARTICLE I.




