ARTICLES OF INCORPORATION

OF

B2G CONNECT, INC.

The Undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

<u>ARTICLE I. CORPORATE NAME.</u>

The name of this corporation is **B2G CONNECT, INC.**

ARTICLE II. PRINCIPAL OFFICE.

The principal place of business and mailing address of this corporation is 2281 NW 53rd Street, Boca Raton, Florida, 33496.

ARTICLE III. DURATION


