
ARTICLE X

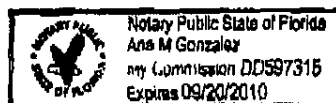


