Corporation Name

Text of Amendment

Adoption of Amendment

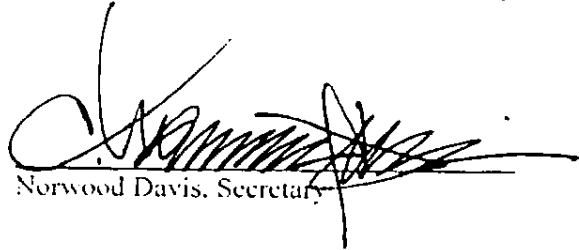
This Amendment was adopted on March 25, 2020 by the sole shareholder and the sole director of the Corporation.
