## ARTICLES OF INCORPORATION

**OF**

## ARTICLE I - NAME

The name of the corporation is BCC Paradise, Inc. (hereinafter called the "Corporation").

## ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under the Florida Business Corporation Act of the State of Florida.

## ARTICLE III - CAPITAL STOCK

The authorized capital stock of this Corporation shall consist of the following classes:

- (a) <u>Class A Common Stock</u>. The Corporation is authorized to issue 100 shares of Class A Common Stock, \$.01 par value. Except as otherwise provided by the Florida Business Corporation Act, each outstanding share of Class A Common Stock is entitled to one vote on each matter submitted to a vote at a meeting of the shareholders.
- (b) Class B Common Stock. The Corporation is authorized to Issue 900 shares of Class B Common Stock, \$.01 par value. Except as otherwise provided by the Florida

Business Corporation Act, outstanding shares of Class B Common Stock shall have no voting rights.

(c) <u>Rights and Preferences</u>. Except with respect to voting, shares of Class A Common Stock and Class B Common Stock shall have the same rights and preferences.

## ARTICLE IV - INITIAL REGISTERED AGENT
