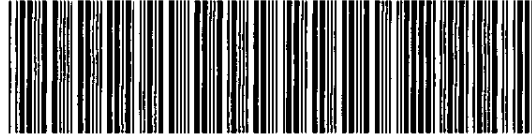

ARTICLE I - NAME, PRINCIPAL ADDRESS AND MAILING ADDRESS

The name of the Corporation shall be AZ DESIGNS, INC. The principal and mailing address of the corporation shall be 30341 Fairway Dr., Wesley Chapel, FL 33543.

ARTICLE II - CAPITAL STOCK


ARTICLE IV - INITIAL REGISTERED OFFICE AND AGENT


