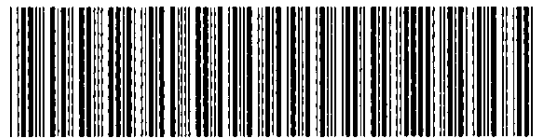

ARTICLE I **NAME OF ORGANIZATION**

ARTICLE III PURPOSE OF ORGANIZATION

III.01 This organization is a sanctioning body and/or an association league for championship bouts .This organization shall adopt a symbol, as a championship belt, to represent a member attaining the highest goal associated with this organization. It shall be announce as SWAGG championship of the world or M-O-B championship or O-N-C-E or LBA championship

III.02 This is a profit organization with the purpose to place opportunity before fighters to contest for a supplementary world championship title, and improve professional boxing championship with an influential prize fighter to champion in activities and in causes. We are dedicated to sponsoring our champions in public addresses, erecting boxing gyms, promoting education, promote equality, ensure workmanship dues, proliferating economics conditions, and eliminate discrimination based off race, origin, and age. Our service is for local, regional or states in possession or in territories of (US) or countries, including Africa, Asia-pacific, Europe and South and Central America.

III.03 In many cases, fighters never will compete for prestige belts because of subordinating ratings or deferred fortune or despairing funding or for other reasons. Therefore, this organization shall establish a rating system of top 50 boxers and divide into three separate classes A Pool, B Pool, and C Pool with fifteen slots in first two pools .these three pools shall be our championship classes. In addition, cost shall be affordable

to promoters and in some cases shall negotiate minimum to benefit all active participants.

III.04 This organization shall show cause in legal authority or power, or right or sway to create a trust fund, in contingency, with the boxing league for purpose of assisting active service boxers before professional careers have properly or completely ended. For the purpose of advancing cause all deputation of promoters shall be members with contractual effects. This legion shall be the beast of burdens that must depend on the promoter(s) and/or must be at the mercy of the promoter(s) endowments. This enactment must moderate pecuniary obligation and responsibility for utilizing a non profit support service for retired boxers in this association.
