Pursuant to Section 607.0202 of the Florida Business Corporation Act, the undersigned hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME.

The name of the corporation is DMT Merger Corporation.

ARTICLE II. PRINCIPAL OFFICE.
