**ARTICLES OF INCORPORATION
OF
ACHIEVEMENT REHABILITATION THROUGH

The undersigned, acting as Incorporator of **ACHIEVEMENT REHABILITATION THROUGH THERAPEUTIC INTERVENTION, INC.** (the "Corporation"), pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation:

ARTICLE I - NAME/ADDRESS

The name of the Corporation is **ACHIEVEMENT REHABILITATION THROUGH THERAPEUTIC INTERVENTION, INC.** The street address of the initial principal office of the Corporation shall be 3424 S. Winding Path, Inverness, Florida 34450.

ARTICLE II - CORPORATE EXISTENCE

The Corporation will exist commencing on the date of filing the Articles of Incorporation with the Florida Department of State.

ARTICLE III - DURATION

The Corporation shall exist perpetually.

ARTICLE IV - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful businesses for which corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE V - CAPITAL STOCK

The maximum number of shares of capital stock that the Corporation is authorized to issue and have outstanding at any one time is Two Hundred Thousand (200,000) shares of Common Stock having a par value of One Cent (\$0.01) per share.

The power to adopt, alter, amend or repeal Bylaws shall be vested in the Board of Directors and the shareholders.

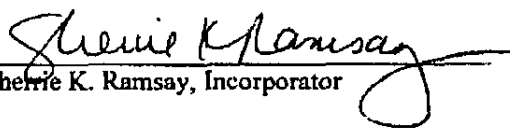
