

ARTICLES OF INCORPORATION

OF

REAL ESTATE RISK MANAGEMENT SERVICES, INC.

Pursuant to the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, the undersigned incorporator of Real Estate Risk Management Services, Inc., a Florida corporation (the "Corporation"), hereby adopts the following Articles of Incorporation for the Corporation:

ARTICLE I NAME AND ADDRESS

ARTICLE II BUSINESS AND ACTIVITES
