

ARTICLE I
Name of Corporation

The name of this corporation is FRITZ LANDSCAPING AND PRESSURE CLEANING INC.

ARTICLE II
Purpose

Organized primarily as a landscaping and pressure cleaning company, FRITZ LANDSCAPING AND PRESSURE CLEANING INC. will, with the approval of its Board, transact any and all lawful business permitted under the laws of the United States and the State of Florida.

ARTICLE III
Capital Stock

Initially, this Corporation is authorized to issue 10,000 shares of common stock at \$0.01 dollar par value.

ARTICLE IV
Corporate existence and Date of Operation

This corporation shall exist for a perpetual period of time. It shall have offices throughout and outside the State of Florida.

ARTICLE V
Capital Stock Voting Rights

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of outstanding common shares.

The directors shall hold office for the first year of existence of the corporation and until their successors are elected or appointed according to the by-laws. 




