

ARTICLES OF INCORPORATION

OF

ARTICLE I

NAME: The name of this corporation is;

HEWITT'S TRUCK REPAIR, CO.

ARTICLE II

The general nature of the business to be transacted by this corporation shall be:

- (a) Repairs and retail sales
- (b) To invest and re-invest funds of this corporation in real estate mortgages, stocks, bonds or any other type of investments within the meaning of chapter 621.08. Florida Statute, and to acquire and own real and personal property necessary for the rendering of such services to facilitate same.
- (c) To do each and everything necessary and proper for the accomplishment furtherance of any of the purpose of objects of this corporation enumerated in these articles of incorporations or any amendments thereof, necessary or incidental to the protection and benefit of this corporation., and, in general either alone or in association with other corporations, firms or individuals, to carry on any lawful pursuits necessary or incidental to the accomplishment of furtherance of such purposes or objects of this corporation.
- (d) To conduct and transact any business lawfully authorize and not prohibited by chapter 621, Florida Statute, as the same may be amended from time to time.

ARTICLE III

The maximum number of shares or stocks that this corporation is authorized to issue and have outstanding at anyone time shall be 100 shares of common stocks having a par value of one dollar

ARTICLE IV

The amount of capital with which this corporation will begin business shall not be less than 100 one hundred shares.

ARTICLE V

This corporation shall have perpetual existence.

ARTICLE VI

The mailing address of the principal office of this corporation in the state of Florida shall be: 2530 NW 16th Blvd., Okeechobee, Florida 34972. The Board of directors may, from time to time move the principal office to any other address in the State.

ARTICLE VII

This corporation shall have one (1) director initially. The number of directors may be either increased or diminished from time to time by the Bylaws adopted by the stockholders, but shall never be fewer than one (1). The names and addresses of the first Board of Directors, who subject to the provisions of the Articles of Incorporation and Bylaws, and the corporate Laws of the State of Florida shall hold office for the first year of the corporation's existence, or until successors are elected.

The number of shares the subscribers agree to take and the value of the consideration therefore is \$100.

ARTICLE X

ARTICLE XII

These articles of incorporation may be amended in the manner provided by law. Every amendment shall be approved by the board of directors, proposed by them to the stockholders, and approved at a stockholder's meeting by at least amajority of the stock entitled to vote thereon, unless all of the directors and all of the stockholders sign a written statement manifesting their intentions that a certain amendment of these articles or incorporation be made.
