**ARTICLES OF INCORPORATION**  
**OF**  
**MAINSTREAM MOTORS, INC.**

**ARTICLE I - NAME**

The name of this corporation is MAINSTREAM MOTORS, INC. (the "Corporation")

**ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS**

The street address of the principal office and the mailing address of the Corporation shall be 200 Yellow Place, Rockledge, Florida 32955.

**ARTICLE III - CAPITAL STOCK**

The capital stock of the Corporation shall consist of the following:

**Common Stock:** A single class of common stock called "Common Stock" and the aggregate number of such shares that the Corporation is authorized to issue is One Hundred Thousand (100,000) shares having a par value of No and 01/100 Dollars (\$0.01) per share. The holders of shares of common stock shall be entitled to one vote for each duly authorized, issued and outstanding share of Common Stock.

**Preferred Stock:** A single class of preferring stock called "Series A Convertible Preferred Stock" and the aggregate number of such shares that the Corporation is authorized to issue is One Hundred Thousand (100,000) shares having a par value of No and 01/100 Dollars (\$0.01) per share. The board of directors of the Corporation is authorized to create and determine the rights, terms and preferences of such shares, including, but not limited to, maturity, conversion, dividend, liquidation redemption, antidilution, voting rights, co-sale agreement and information.

**ARTICLE IV - INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of the Corporation is 200 Yellow Place, Rockledge, Florida 32955, and the name of the initial registered agent of the Corporation at that address is Robert J. Scaringe.

**ARTICLE V - INITIAL BOARD OF DIRECTORS**

The Corporation shall have three (3) directors initially. The number of directors may be either increased or decreased from time to time as provided in the Bylaws of the Corporation, but shall never be less than one (1). The names and addresses of the initial directors are as follows:
