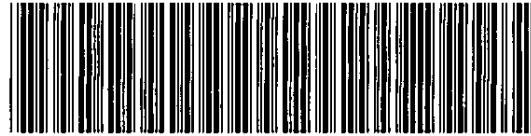

**ARTICLE I**  
**CORPORATE NAME, PRINCIPAL OFFICE**  
**AND MAILING ADDRESS**

The name of this Corporation shall be: **TEBO MASTER HANDYMAN, INC.**, with its principal office located at 2299 S. Glencoe Road, New Smyrna Beach, Florida 32168 and its corporate mailing address being the same.

**ARTICLE II**



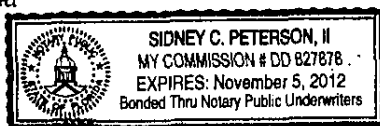


