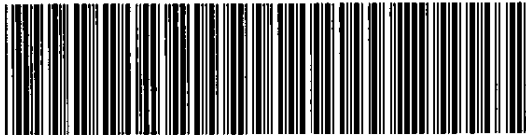



Dear Colleagues:

Governor Scott has directed the Department of Management Services to close state executive buildings on Friday, December 23, 2011.

All employees released from duty on that day will be granted paid administrative leave. Because there are essential services that the state must continue, those employees who are required to work that day will be permitted to take an equivalent amount of administrative leave within the next six months. Any leave not taken by June 30, 2012, will be forfeited.

Since there is typically a low utilization of state buildings during the holidays, this action will have the added benefit of utility cost savings.
