ARTICLES OF INCORPORATION OF ODYSSEY EVENTS AND PROMOTIONS, INC.

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby

form a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is ODYSSEY EVENTS AND PROMOTIONS, INC.

ARTICLE II

- A. This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.
- B. The general nature of this business to be transacted by this corporation is: the organization of events and promotions of events in the U.S. and any other activity that is legal.


