**ARTICLE I - NAME OF CORPORATION**

The name of the corporation is **LIVING STONE NEPHROLOGY AND

**ARTICLE II - NATURE OF BUSINESS**  
**MEDICAL CONSULTANTS**

The corporation is authorized to conduct any lawful business in the State of Florida which is not prohibited by law, rule or regulation.
