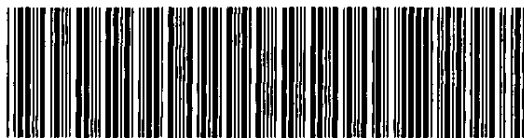

ARTICLES OF INCORPORATION  
OF

ARTICLE I. NAME

The name of this corporation is CHRISTIE'S CLEANING SERVICE INC.

This corporation shall have perpetual existence.


