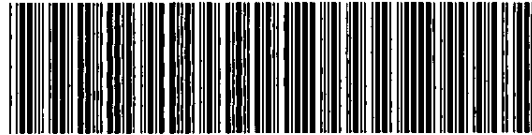

I, the undersigned incorporator, hereby form, organize, and incorporate, a Florida profit corporation, under the laws of the State of Florida, by and under the Florida Business Corporation Act

ARTICLE I – NAME

The power to adopt, alter, amend or repeal Bylaws shall be vested in the Board of Directors and the shareholders.


ARTICLE X – AMENDMENT
