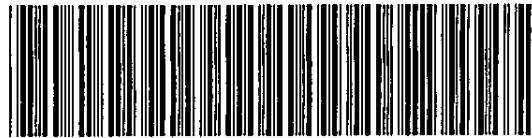

ARTICLES OF INCORPORATION

under the Florida General Corporation Act, adopt the following
Articles of Incorporation for such Corporation.

ARTICLE I. NAME.


