The undersigned incorporators, David R. Wise and Debra L. Wise, natural persons competent to contract, hereby present these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is BUCKHEAD HOLDINGS, INC.

ARTICLE II - PRINCIPAL OFFICE

The street address of the principal office of the corporation is 127 North Partin Drive, Niceville, Florida 32578, and the mailing address of the corporation is P.O. Box 884, Niceville, Florida 32580-0884.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.

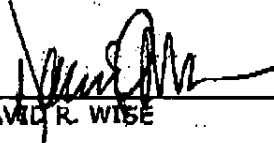
