ARTICLES OF INCORPORATION EAST ARLINGTON, INC.

The undersigned Incorporator of East Arlington, Inc., hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be East Arlington, Inc. ("Corporation"). Its initial place of business shall be 13799 Beach Boulevard, Jacksonville, Florida 32224.

ARTICLE II

The officers of the Corporation shall be a President and a Secretary/Treasurer, and any other offices as may be established by the Board of Directors from time to time. The initial President shall be David L. Young and the initial Secretary/Treasurer shall be Grady R. Kearsey.
