The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a professional association (herein called the "Association") under Chapters 607 and 621, Florida Statutes, in the practice of dentistry.

Article I - Name

The name of the Association shall be Family Dentistry of Central Florida, P.A. The principal place of business of this Association shall be 2141 East Fort King Street, Ocala, FL 34471.

Article II - Principal Address of Business

The Association's street address for its principal office and mailing address is 2141 East Fort King Street, Ocala, FL 34471.

Article III - Nature of Business

The purposes for which the Association is formed are to practice the profession of dentistry and to:

- Engage in every phase and aspect of the general practice of dentistry; provided, however, that the professional services involved in the Association's practice of dentistry shall be rendered only through those of its directors, officers, employees and agents who are duly licensed and authorized to practice dentistry in the State of Florida; and
- Invest the funds of the Association in real estate, mortgages, stocks, bonds
 and any other types of investments and to purchase, own, hold, rent, lease

- however, that such investments and property are necessary for or incidental to the practice of dentistry by this Association; and
- Engage in any lawful act or activity for which professional corporations or associations may be formed under Chapters 607 and 621 of the Florida Statutes.

Article IV - Capital Stock

The maximum number of shares of stock that this Association is authorized to have outstanding at any one time is one thousand (1,000) shares of common stock, without par value.

Article V - Address of Registered Agent

The street address of the initial registered office of the Association shall be the same as its principal office, and the name of the initial registered agent of the Association at that address is Eric Zendell, D.D.S.

Article VI - Term of Existence

This Association is to exist perpetually.

Article VII – Limitations on Stock

The Association may issue its capital stock only to persons who are duly licensed or otherwise legally authorized to practice dentistry in the State of Florida. A Shareholder of the Association may sell or transfer his shares only to other individuals who are duly licensed and otherwise legally authorized to practice dentistry in the State of Florida.
