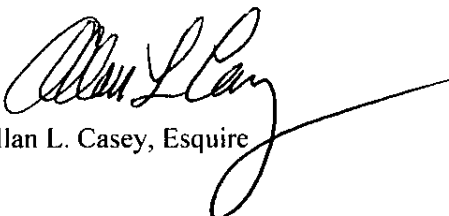

KNOW ALL MEN BY THESE PRESENTS: that the undersigned, acting as incorporator of a Corporation under Chapter 607 of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

**ARTICLE I. NAME**

The name of this Corporation is: **CLEAR BLUE KNOWLEDGE, INC.** whose street address is: 700 South Ilakee Avenue, Lake Alfred, Florida 33850.

**ARTICLE II. NATURE OF BUSINESS**

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

**ARTICLE III. CAPITAL STOCK**

The total unauthorized capital stock of this Corporation shall be one hundred (100) shares of common stock at One Dollar (\$1.00) par value, all of said common stock fully paid and non-assessable.

**ARTICLE IV. PREEMPTIVE RIGHTS**

The shareholders of this Corporation shall have preemptive rights to the Corporation's common stock.

**ARTICLE V. TERM OF EXISTENCE**

The Corporation shall have perpetual existence, unless sooner dissolved according to law.
